2009 Saskatchewan Legislative Interns

2009 Highlights

- In 2009, the Saskatchewan Legislative Internship Program completed its eighth consecutive year of operations.
- Five interns participated this year. Since its inception and including this year's interns, the Program's alumni now consist of 34 interns who have been mentored by 39 current and former members of the Legislative Assembly of Saskatchewan. - Three new program sponsors joined the Program in 2009: the Canadian Study of Parliament Group, the Saskatchewan Association of Health Organizations, and the Saskatchewan Chamber of Commerce.
- The comparative study tour took the interns to Berlin (Germany) for the first time. They also travelled to Ottawa and London.
- The Saskatchewan Legislative Internship Program Advisory Committee approved a policy to provide an allowance to facilitate participation in the Program by interns who have childcare requirements and other special needs.

Overview of the Program

The Saskatchewan Legislative Internship Program (SLIP) provides at least five senior university students or recent graduates with an opportunity to experience the day-to-day operations of the Legislative Assembly of Saskatchewan. Interns are paired with elected members of the Assembly who serve as mentors and provide a practical perspective on the role and work of MLAs. During their seven-month internship, participants are assigned for approximately three months with an MLA from the government caucus and for another similar period with an MLA from the opposition caucus.

In addition to the practical experience provided through the MLA mentors, the Program contains significant academic components. The interns receive six academic course-credits at either the University of Saskatchewan or the University of Regina. These credits are determined through evaluations of the interns' participation during the Program and through the preparation of an individual research paper and group reports on assigned projects and travel experiences. One of the travel experiences involves visiting parliaments and legislative assemblies in other jurisdictions in order to allow for comparisons with their internship experiences in Saskatchewan.

2009 Interns and Mentors

Our 2009 Saskatchewan Legislative Interns

Interns are chosen by a seven-person selection committee from applications received each year. For 2009, this committee selected five Saskatchewan Legislative Interns, including a Rawlco Aboriginal Saskatchewan Legislative Intern.

The five students who were selected to participate in the 2009 Program were:

Ms. Tootoosis was selected as the Rawlco Aboriginal Saskatchewan Legislative Intern.

Our 2009 Legislative Mentors

Four members of the government caucus and five members of the opposition caucus within the Legislative Assembly of Saskatchewan volunteered to serve as mentors to the 2009 interns. The MLAs were assigned to the interns as follows:

Five MLAs – Buckley Belanger, Michael Chisholm, Warren Michelson, John Nilson, and Nadine Wilson – served as mentors to Saskatchewan Legislative Interns for the first time this year. Taking into account their participation in previous years, Warren McCall and Judy Junor mentored their third intern and Glen Hart mentored his fourth intern in 2009. Sandra Morin volunteered as a mentor for her fifth intern and currently holds the distinction of mentoring the largest number of interns since the inception of the Program.

We could like to thank the MLAs who served as mentors during the 2009 Saskatchewan Legislative Internship Program. They and their staff are an integral part of the Program which would not exist without their support.

2009 Program

Orientation Component

The Office of the Clerk of the Legislative Assembly organized orientation meetings for the interns, most of which took place during the first two weeks of the internship. The orientation component of the Program included meetings with Mr. Speaker, staff and officers of the Legislative Assembly, representatives of government and opposition caucuses, and representatives of the news media and of central agencies in executive government. A list of the people who met with the interns is provided in Appendix C.

Core Component

The interns began their assignments with five members of the Legislative Assembly (two from the government caucus and three from the opposition caucus) on January 19, 2009. These assignments continued until April 10, 2009. The interns were then reassigned to another four members from the other side of the House (two from the government caucus and two from the opposition caucus). Fewer members participated in the second term because the Rawlco intern did not complete the Program. The second term assignments concluded on July 3, 2009.

During their assignment to private members, the interns were given opportunities to accompany their assigned members to meetings, conferences, and consultations. The interns also visited constituency offices and experienced the work that MLAs do to address the concerns and interests of their constituents. All expenses incurred by the interns in participating in these events and activities were paid by the Program.

Academic Component

The Saskatchewan Legislative Internship Program provides interns with six academic credits towards an undergraduate degree, through its recognition as a course at the University of Saskatchewan (Political Studies 382.6) and the University of Regina (Political Science 480). Interns are required to register in one of these courses in order to participate in the Program. In addition to the course credits, enrolment in these courses provides each intern with student benefits, such as liability insurance, Workers' Compensation coverage, and health benefits.

At the end of the internship, each intern received a grade which recognized his or her participation in the program. Each intern’s final grade was determined by the director, based on the following weighting:

Intern Development Component

The intern development component is undertaken through a special fund (“intern development fund”), which is supported by university, corporate, and organizational sponsors, as well as donations from individuals. The fund is managed for the Program by the University of Saskatchewan.

In-Province Experiences

The intern development fund is used to support special projects that are identified by the interns to enhance their experience in the Program. These projects include transportation and accommodation costs related to the interns' travel to other jurisdictions, as well as attendance at workshops, conferences, meetings, and consultations with major organizations and with people in leadership positions from various sectors of Saskatchewan. The interns are responsible for all of the logistical arrangements associated with these projects.

In 2009, the interns' in-province experiences included attending the following conventions and events as observers/visitors:

The interns attended several events sponsored by the Johnson-Shoyama Graduate School of Public Policy. These events included presentations by Dr. Evelyn J. Peters ("Aboriginal People in Cities: Myths, Realities and Implications for Public Policy"), Dr. Don Lemmen and Dr. Dave Sauchyn ("Climate Change: Impacts and Adaptation in Saskatchewan and Canada"), and Dr. Cory Neudorf ("Overcoming Disparities: What Policy Analysts Can Do So That Policy Leaders Can Act").

The 2009 interns were also provided the opportunity to meet with the following community and political leaders:

The interns have filed a report on their attendance at various conventions and events, as well as their meetings with several leaders.

Out-of-Province Experiences

An important element of the Program's intern development component is the comparative study tour which involves the interns' travel to other jurisdictions. The purpose of this tour is to allow the interns to compare legislative and government processes against those which they have observed and experienced in Saskatchewan. The tour is organized by the interns and is funded through the intern development fund and through additional fund-raising undertaken by the interns.

In the past, the comparative study tour has included, in various combinations, travel to Toronto and Ottawa (Canada), Washington (U.S.A.), London (England), Edinburgh (Scotland), and Belfast (Northern Ireland). In 2009, the interns travelled to Ottawa, London (England), and Berlin (Germany). The interns have filed a report on their tour, which can be accessed through the Program's website. A list of meetings and events attended by the interns during their tour is provided in Appendix D.

Community Services Component

Each year, the Saskatchewan Legislative Interns are required to participate in a community-based activity in a volunteer capacity. In addition to providing personal support, the interns have an opportunity to learn about the objectives, structure, administration, challenges, and successes associated with a community event or organization.

This year, the interns participated in the United Way of Regina's Day of Caring. The interns volunteered to paint a room within the SCEP Centre which is located in the basement of Coronation Park School in Regina. The Centre provides an early intervention, preschool program for children with socialization, communications, and educational problems.

In addition to serving as volunteer painters during the Day of Caring, the interns arranged for the purchase of painting equipment and supplies. These purchases were financed from the net proceeds of the SLIP-MLA steak night event.

Administrative Component

The interns perform various administrative duties pertaining to the operation of the Program. These duties vary from year to year depending on the Program's administrative requirements which cannot be otherwise provided through its existing support.

While individual interns assumed lead responsibility for managing a specific administrative duty, all interns were expected to assist their colleagues to ensure that the activities associated with these duties contributed to the Program's overall success.

2009 Special Events

SLIP Interns' Initial Briefing Event

The 2009 interns met in Saskatoon in November 2008 for an introductory briefing on the Program and to begin making plans for their future internship. This meeting provided an opportunity for the Program to host a lunch to recognize the support it receives from academics and administrators at the University of Saskatchewan. In addition to the SLIP interns and the Program's administrators, representatives from the College of Arts and Science (communications), the Johnson-Shoyama Graduate School of Public Policy, and the Department of Political Studies attended the luncheon.

SLIP Introductory Event

The Johnson-Shoyama Graduate School of Public Policy hosted a welcoming reception in Regina for the 2009 interns on January 26, 2009. Individuals involved in the orientation presentations, MLAs, sponsors, and former interns were invited to meet the interns.

We would like to thank Michael Atkinson (Executive Director), Dan Perrins (Director of Outreach and Training), and Andrea Geisbauer (Manager of Outreach and Training) for organizing this event for the 2009 interns.

SLIP-MLA Steak Night

Each year since 2007, the Saskatchewan Legislative Interns have organized a SLIP-MLA steak night event which provides an opportunity for Members of the Legislative Assembly to have an informal supper with current and former interns and other supporters of the Program. The net proceeds from this event are used by the interns to enhance their experience during their comparative study tour. The money can be used to finance entry to museums, side-tours to significant points of interest, or attendance at cultural or sporting events occurring at the time of the tour.

This year's steak night was held on April 21, 2009 at Bushwakker's Brewing Co. Ltd. in Regina. Seventy-three tickets to the event were sold – of these, 25 were purchased by MLAs and seven (7) by former interns. After expenses, the event generated net proceeds of \$907.20. The interns used these proceeds to rent a canoe for use on the Rideau Canal and to purchase admission to the National Art Gallery in Ottawa. In London, the funds were applied towards the admission to several plays at Shakespeare's Globe Theatre, to the Tower of London, and to a performance by the Royal Ballet at the Royal Opera House. In Berlin, the net proceeds from the Steak Night were applied towards tours of Berlin and the former Sachsenhausen concentration camp, a performance of "Don Giovanni" at the Komische Opera, and admission to a Salvador Dali art exhibit.

Meeting with Representatives of The Co-operators Group

The Co-operators Group was the first non-government and non-university financial contributor to the Saskatchewan Legislative Internship Program and has continued to provide financial support to the program every year since. In total, the Co-operators have provided a total of \$24,000 to the Program, all of which has been channeled towards the cost of the interns' travel to visit legislatures outside of Saskatchewan.

On May 19, 2009, Mr. Frank Bomben (Director of Public Affairs and Government Relations) and Ms. Maya Milardovic (Government Relations Specialist) with The Co-operators met in Regina with the 2009 interns and the Program's director. The supper meeting provided an opportunity for the interns to learn more about The Co-operators, their historic roots in Saskatchewan, and their commitment to supporting internship programs across the county.

Mr. Bomben and Ms. Milardovic reconfirmed their support for the Program's objectives. They also offered to assist in seeking additional funding for future SLIP internship.

Alumni Support and Engagement

Former interns ("alumni") are invited to all public events sponsored by the Saskatchewan Legislative Internship Program. They participate annually in a luncheon event with the current interns, as part of the orientation component of the Program.

An alumni newsletter, known as the *Alumni Report*, is published by the Program and is distributed to all former interns. It is also posted on SLIP's website. The 2009 edition of the *Alumni Report* was published in December 2009.

The purpose of the newsletter is to provide an on-going link between former interns and the Program. Alumni are profiled in the newsletter. Through their accomplishments, we are able to promote the career-development potential of the Program to students and potential sponsors.

Core Program

The Legislative Assembly of Saskatchewan provides funding for scholarships for four Saskatchewan Legislative Interns (\$14,000 each in 2009), for all expenses incurred by these interns during their mentorship with private members of the Assembly, and for the honorarium and expenses of the Program's director.

Rawlco Radio provides scholarship funding and direct core and intern-development expenses for the Rawlco Aboriginal Saskatchewan Legislative Intern. This funding permits the Program to consider adding one additional internship position for a First Nations or Métis applicant who meets the internship criteria as determined by the SLIP Selection Committee. The Rawlco funding was provided to accommodate a Rawlco intern in each of two years. The 2009 Rawlco intern is the second student funded through this arrangement.

Intern Development

Most of the funding for the intern-development component of the Saskatchewan Legislative Internship Program is generated through initiatives and requests undertaken by the Program's director and other supporters. Another source of intern-development funding is obtained through direct application by the interns to financial programs that support student travel experiences, such as those offered by the Program.

The Canadian Study of Parliament Group is a first-time program sponsor in 2009. This sponsorship involves providing the Saskatchewan Legislative Interns with complimentary memberships and copies of its publications, as well as reduced rates for the interns to attend the Group's conferences.

The Saskatchewan Organization of Health Organizations and the Saskatchewan Chamber of Commerce also became program sponsors for the first time in 2009. Both organizations provided observer status, including registrations and meals, for the interns to attend their conferences.

As part of the alumni program for the Saskatchewan Legislative Internship Program, former interns are being encouraged to consider making tax-deductible donations to support the Program. Patrick Button, a 2008 intern, is the first former intern to make such a donation.

2008-09 Financial Statements

The Saskatchewan Legislative Internship Program's statement of revenues and expenses for the period from October 1, 2008 to September 30, 2009, inclusive, has been provided in Appendix B of this report. The Program's finances are managed through four funds. The core program is funded by the Legislative Assembly of Saskatchewan. The funding received from financial partners, corporate sponsors, and donors for the intern development fund and the Rawlco Aboriginal internship fund is managed by the University of Saskatchewan. A credit union account has been established to manage the interns' fund-raising activities.

During 2008-09, the four funds realized revenues of \$114,919.98 and expenses of \$100,403.19, for an overall surplus of \$14,516.70. Of this surplus, \$13,958.05 was attributed to the Rawlco internship fund and resulted from the Rawlco intern not completing the 2009 internship.

The balance sheet for the intern development fund, the Rawlco Aboriginal internship fund, and the interns' fund-raising account has also been provided in Appendix B. The core component of the Program is fully funded by the Legislative Assembly of Saskatchewan and as such, ends each year without a surplus or a deficit.

The intern development fund has been in existence since the Program began and had an accumulated surplus of \$11,935.17 as at September 30, 2009, up from \$11,382.32 a year earlier. The Rawlco Aboriginal internship fund ended 2008-09 with \$15,813.82; the increase from the previous year was due to unexpended funds resulting from a partially-completed internship. The interns' fund-raising account ended the year with cash of \$11.90 and a membership share of \$5.00. The combined accumulated surplus for all funds was \$27,765.89 on September 30, 2009; this compares with \$13,249.10 on September 30, 2008.

Governance

Memorandum of Agreement

The Saskatchewan Legislative Internship Program exists through a memorandum of agreement between the University of Saskatchewan and the University of Regina. The memorandum, signed in 2007, formalizes the universities' support for, and participation in, the Program. The agreement articulates the role of the director and the SLIP Advisory Committee, the academic credits provided by both universities to the Program's interns, the provision of liability insurance coverage to the interns, and the administration of the Intern Development Fund.

Saskatchewan Legislative Internship Program Advisory Committee

The Speaker of the Legislative Assembly serves as the chair of the committee.

During the 2008-09 fiscal year, the SLIP Advisory Committee met on December 2, 2008. The Committee reviewed the 2009 SLIP annual report and considered the recommendations to reappoint the Program's director for a second three-year term. The committee considered options for addressing concerns by previous interns regarding the use of gymnasium facilities at the University of Regina by Saskatchewan Legislative Interns who are not registered as students of that university. Also, the committee adopted a policy of providing an allowance of up to \$500 per month to facilitate the participation in the Program by interns with childcare and other special needs; requests for this allowance will be evaluated on a case-by-case basis, with the decision being made administratively.

Saskatchewan Legislative Internship Program Selection Committee

Applications for the internships are accepted from university students and recent graduates who identify Saskatchewan as their permanent residence. The applications are reviewed by the Saskatchewan Legislative Internship Program Selection Committee which reviews all applications, creates a short-list of applicants who will be considered for the Program, conducts interviews of the short-listed applicants, and makes the decisions on the applicants who will be offered internship positions. The decisions of this Committee are final and are not subject to review or reconsideration by funders, sponsors, elected members of the Legislative Assembly or any other body or program or other elected or appointed bodies who participate with the Program.

The members of the Selection Committee are nominated by various university, administrative, and caucus bodies associated with the program. Upon selection to the committee, the members are not accountable to these bodies, but rather to the Program and to ensuring that the best possible applicants are offered internship positions.

The SLIP Director serves as the chair of this committee.

For the 2009 internship program, the Committee considered 20 applications. Of these applications, 11 were from students or recent graduates of the University of Saskatchewan and 9 from the University of Regina. One of the applicants (from the University of Saskatchewan) self-declared as an Aboriginal applicant and therefore, as being eligible for the Rawclo Aboriginal Saskatchewan Legislative Internship.

Officers and Staff

The Hon. Don Toth, Speaker of the Legislative Assembly of Saskatchewan, serves as the honorary patron of the Saskatchewan Legislative Internship Program. He is also the chair of the Saskatchewan Legislative Internship Program Advisory Committee.

Mr. Ken Pontikes serves as the director of the Program and chair of the Saskatchewan Legislative Internship Program Selection Committee. Mr. Pontikes has been appointed to the director position by the Speaker of the Legislative Assembly. This appointment is made from a joint recommendation of the University of Saskatchewan and the University of Regina and following a review by the SLIP Advisory Committee. Mr. Pontikes is serving in his second term as director, with the appointment continuing until October 31, 2011.

The Saskatchewan Legislative Internship Program does not directly employ any staff. Staff support is provided through the universities and the Legislative Assembly of Saskatchewan. The staff support for 2009 was provided by the following individuals:

SASKATCHEWAN LEGISLATIVE INTERNSHIP PROGRAM 2009 INTERNS

Dawn Gibbons spent her early years on a dairy farm near Battleford. Her family later moved to North Battleford where she graduated from the Convent of the Child Jesus. She then began pursuing a degree in political studies at the University of Saskatchewan.

Her university education was interrupted to raise a family of three children and to complete a business certificate at SIAST. In 2008, she received her Bachelor of Arts (Honours) degree in political studies. Dawn is currently a Master of Business Administration candidate at the University of Saskatchewan.

Dawn has an extensive background in the non-profit sector. She has been employed as a fund-raising coordinator for the Saskatchewan Heart and Stroke Foundation and as a marketing and volunteer recruitment coordinator for the Canadian Red Cross Society and for the Canadian Blood Services. Between 2005 and 2007, she was the executive director of the Battlefords Union Hospital Foundation. In 2008, she was employed by the St. Paul's Hospital Foundation in Saskatoon.

"I think there are many things I will take with me from this internship. I have made some excellent contacts and I have also made new friends. If I become involved in community work, I will know how to navigate the political landscape should the need arise. I am not yet sure if I will pursue employment with the public service, but I have a better understanding of the nature of this service and thus, I am more sympathetic to the idea of being a part of this system. Overall, my knowledge about public life has matured."

Dawn has worked as a project manager for a local community development association, Community Connections Inc., and as an inner-city school coordinator at St. Mary Community School in North Battleford. As a school coordinator, she assisted with the development of a low-income cooperative housing association, aboriginal leadership initiatives, and many community and school improvement projects, including community gardens, community and in-school family literacy projects, family violence and school bullying awareness initiatives, and community-wide and in-school aboriginal cultural events. During the 2003-04 school year, she was recognized by elders during the First Nations University of Canada's pow wow for her significant contribution to Aboriginal leadership in Saskatchewan.

Dawn's volunteer work with a number of community charities and community organizations contributed to developing her skills as a fund-raiser and organizer. Dawn also has employment experience in two family businesses, as well as several other businesses within the Battlefords area.

Nicole Leach is from Regina. She graduated from Michael A. Riffel High School in 2004, where she was an honour roll student.

Throughout her high school career, Nicole swam competitively with the Regina Optimist Dolphins Swim Club. Nicole stopped swimming competitively in 2003, but continued with the swim club as a coach for the younger swimmers. She also spent her summers as a lifeguard at Maxell's Amusements' waterslides. Nicole has coached for the Girl Power Program, where girls from five different inner city schools in Regina participate once a week in selected water sports over a nine-week period.

Nicole is currently attending the University of Regina where she is working towards obtaining a Bachelor of Arts Degree, double majoring in political science and economics. For the 2008-09 school year, Nicole was elected as co-vice-president for the Political Science Students' Association at the University of Regina. Nicole has been actively involved with the University of Regina Women's Centre.

While working to complete her degree, Nicole has chosen employment opportunities to complement her studies, including holding positions with the Saskatchewan Department of Labour and with the Paul Dojack Youth Centre. She has also worked for the Co-operator's Life Insurance Company and in 2007 received one of two annual scholarships from the Co-operators.

Nicole is part-owner of a family entertainment and concession business, Jennic & Company, which performs magic shows and operates a concession booth at events in Regina and in various other communities across Saskatchewan.

Nicole received the High Noon Optimist Club of Regina's annual scholarship in 2004. Nicole also received the 2004 Union of Taxation's National Scholarship.

Recently, Nicole served as a volunteer with the Boys and Girls Club of Regina. She is also a contributor and volunteer with the Regina Streets Magazine.

"It was definitely an eye-opening experience. Good or bad, my time around politicians and political parties has opened my eyes to a world of information that I did not know existed. I have to admit that it was one of the steepest learning curves that I have ever encountered. I had the opportunity to work on a lot of interesting projects, to meet a lot of amazing people, and to go to a number of informative events."

Michael Radmacher was born and raised in Regina. He attended Campbell Collegiate, where he received class pins for high academic achievement. During his high school years, Michael was very active with several music groups, including The Classics and Chamber Choir. He was also the assistant concertmaster of the South Saskatchewan Youth Orchestra (SSYO). Following high school, Michael attended SIAST where he received his Primary Care Paramedic diploma.

In June 2008, Michael convocated from the University of Regina with a Bachelor of Arts degree (High Honours in Political Science, with a minor in History). His studies focused on race relations, decolonization and feminist theories.

In 2009, Andrew completed a Bachelor of Arts (Honours) degree, with a major in political studies, at the University of Saskatchewan. He has been a member of the Golden Key International Honour Society which recognizes students with academic excellence in their fields of study.

"The internship was extremely valuable and worthwhile to me for many different reasons. It provided me work experience in an office environment and in my field of interest. The internship enhanced my writing, communications, research, and organizational skills. The non-partisanship nature of the internship and my personal connections with different people will also help my future career."

Through the summer months, Andrew is an employee of the Saskatoon Airport Authority. He maintains year round employment through an evening shift at Purolator Courier.

Andrew is actively involved with several of Saskatoon's community organizations and events. Andrew has volunteered with Oxfam Canada, the Friendship Inn, the Sherbrooke Community Centre, the Canadian Cancer Society, the Canada Remembers Air Show, and the Saskatoon Exhibition Parade. Notes to Financial Statements:

1. All cash for the Intern Development Fund and for the Rawlco Aboriginal Internship Fund are being held, on behalf of the program, by the University of Saskatchewan.
2. The interns organized a fund-raising event to provide supplementary financing for their comparative study tour. A “steak night” for members of the Legislative Assembly of Saskatchewan and other supporters of SLIP was held on April 21, 2009. The event generated a surplus of \$914.20 (revenues of \$1771.00 less expenses of \$856.80) for the interns. These funds can be used to finance entry to museums, side-tours to significant points of interest, or attendance at cultural or sporting events occurring during their comparative study tour.
3. The Program received in-kind support from the Canadian Study of Parliament Group, the Johnson-Shoyama Graduate School of Public Policy, the Saskatchewan Association of Health Organizations, the Saskatchewan Chamber of Commerce, and the Saskatchewan Urban Municipalities Association. The value of this in-kind support is not included in the SLIP financial statements.
4. The interns who are registered students of the University of Regina are eligible to apply for travel grants from the University of Regina Students’ Union, the International Student Success Office, and the Goldman Travel Fund. These amounts were directly granted to the interns. With the exception of the Goldman Travel Fund, these grants were deposited into the Interns’ Fund-raising Account. The Goldman Travel Fund’s grant was deposited directly to the Intern Development Fund. All amounts from these grants were used to finance eligible comparative study travel expense incurred by the University of Regina’s interns through the Intern Development Fund. Similar sources of travel funding were not identified for the interns who are registered at the University of Saskatchewan.
5. A Rawlco Aboriginal Saskatchewan Legislative Intern was selected for 2009, but did not complete the internship. The \$13,958.05 surplus in the Rawlco Aboriginal Internship Fund represents funds which were not expended during the 2009 internship period. A request will be made to Rawlco Radio to have these funds, as well as a surplus realized in a previous period, (for a total of \$15,813.62) applied to a future internship, when a Rawlco Aboriginal Legislative Intern is selected.
6. An account held by the Affinity Credit Union is used to manage the interns’ fund-raising activities. At the end of the fiscal year, the account had a balance of \$16.90 which consisted of the account’s \$5.00 membership fee and \$ 11.90 in cash available for use in a future year.
7. Intern selection expenses pertain to the travel, accommodation, and meal costs associated with interviewing candidates for the 2010 internship. These costs were incurred in 2008-09 by candidates and by members of the Program’s selection committee.
